Privacy Policy

Overview

Horsell Sings! is a registered charity governed by the Charity Commission of England and Wales with registration number 1205511. This privacy policy will explain how our organisation uses the personal data we collect from you when you complete your membership registration or access our website.

What data do we collect?

Horsell Sings! collects the following data when you complete your membership registration:

- Personal identification information
- Emergency contact information
- Permissions and Preferences

How do we collect your data?

We only collect and process data from you when you register on-line via our membership registration form or provide a completed membership application form in person or by email. We also use “cookies” – see below – to improve your experience when you access our website.

How will we use your data?

Horsell Sings! collects your data so that we can identify your membership accurately. This enables Horsell Sings! to communicate with you by post, email or optionally WhatsApp on choir-related matters such as fees, dates for rehearsals, concerts and meetings and make available shared resources such as songs, recordings and other material that the trustees wish to share with you as part of your membership package.

What are your data protection rights?

Horsell Sings! would like to make sure you are fully aware of all of your data protection rights. Every member is entitled to the following:

The right to access – you have the right to request Horsell Sings! for copies of your personal data,

The right to rectification – you have the right to request that Horsell Sings! corrects any information that you believe is inaccurate, or completes information that you believe is incomplete.

The right to erasure-you have the right to request that Horsell Sings! erase your personal data under certain conditions,

The right to restrict processing - you have the right to request that Horsell Sings! restrict the processing of your personal data, under certain conditions,

The right to object to processing - you have the right to object to Horsell Sings! processing of your personal data, under certain conditions.

The right to data portability - you have the right to request that Horsell Sings! transfers the data that we have collected to another organisation, or directly to you, under certain conditions.

What are cookies?
